WHEREAS, the mission of the Department of Neighborhoods is ~~to empower people to make positive contributions in their communities and neighborhoods, support and build inclusive partnerships across the City, and bring government close to all people in a way that ensures in order to provide Seattle communities with~~ equitable access to government resources; ~~and~~

WHEREAS, a focus on equity is essential to any community involvement process in order to build relationships and improve outcomes, especially for under-represented and under-served communities, including, but not limited to, renters, immigrants and refugees, communities of color, people experiencing homelessness, LGBTQ persons, low-income households, youth, and seniors; and

WHEREAS, Resolution 27709, adopted in 1987, Resolution 28115, adopted in 1989, and Resolution 28948, adopted in 1994, established a process for dividing Seattle into 13 neighborhood District Council districts, each with a District Council comprised of ~~community councils, neighborhood business organizations, and other organizations that wish to participate. Local residents, business owners and other community members that provide~~ Each district council also sends a representatives to the citywide City Neighborhood Council; and

13 that barriers that discourage people from participating are eliminated; and

14 WHEREAS, the public involvement programs and practices advanced by City departments

15 should reflect Seattle's commitment to the Race and Social Justice Initiative, which

16 focuses on ending structural racism and race-based inequities both within City

17 government and across the community; and

18 WHEREAS, as part of the City's 2016 Adopted Budget, the City Council requested that the

19 Department of Neighborhoods develop a plan to provide more equitable community

20 engagement, with a particular focus on Department of Neighborhoods staff resources

21 assigned to support the District Council system; and

22 WHEREAS, on July 13, 2016, Mayor Murray issued Executive Order 2016-06 directing the

6 Section 3. Section 3.35.050 of the Seattle Municipal Code, last amended by Ordinance
7 117977, is amended as follows:

8 **3.35.050 Neighborhood Matching Subfund ((-))**

9 A. There is hereby established in the City Treasury, as a subfund of the General
10 Fund, a Neighborhood Matching Subfund to be administered by the Director of the Department
11 of Neighborhoods and into which shall be deposited whatever sums the City may receive or
12 allocate from time to time or during the annual budget process ~~((for neighborhood planning and~~
13 ~~assistance purposes))~~ .

14 B. Disbursements from the Neighborhood Matching Subfund shall comply with
15 all applicable provisions of the State Constitution, State law, City Charter, and ordinances of
16 the City, and shall be made from appropriations authorized by the City Council by
17 ordinance.

18 C. Funds appropriated from the Neighborhood Matching Subfund shall not lapse
19 and shall be carried over each year until fully expended, reallocated by administrative
20 action, or abandoned or reappropriated to other authorized activities.

21 D. There is hereby established in the Neighborhood Matching Subfund a new
22 account called the Neighborhood Participation Account into which shall be deposited any



9 which are composed of representatives of community councils, neighborhood business
10 organizations~~districts~~ and other community-based organizations that represent people or
11 businesses with an interest in the neighborhood districts shown on Map 1 of Section 3.35.055.

10 recommendations to the Mayor and City Council on the development of plans, policies,
11 regulations, strategies, and community grant funding processes that advance equitable public
12 engagement and civic participation in ((the)) The City of Seattle. ~~An early part of the~~
13 Commission's task will be to review the performance of the District Councils and the City
14 Neighborhood Council and make a recommendation as to whether they should continue as
15 official City advisory bodies and if so, in what ways they should be improved. The Commission
16 shall act in an advisory capacity only.

17 **3.62.020 Membership**

18 A. The Commission is comprised of 16 members. Appointments shall be made to
19 ensure that varied community perspectives are represented. At least one position shall be held by
20 a representative from each of the seven City Council districts. If a member cannot be found from
21 a particular district, that seat will remain empty. Appointments shall be made, to the extent
22 possible, so that the Commission membership reflects the current demographics of the City,
23 including consideration of historically underrepresented communities.

2 **3.62.030 Appointment and term**

3 A. All positions are numbered one through 16. Individuals shall be appointed into
4 those numbered positions. Members in positions one through seven shall be appointed by a
5 majority vote of the Council, with each member representing the City Council district that
6 corresponds to their position number. Individuals in positions eight through 14 shall be appointed
7 by the Mayor, subject to confirmation by a majority vote of the Council. Position 14 shall be
8 filled by a young adult pursuant to the Get Engaged Program in Chapter 3.51. Members in
9 positions 15 and 16 shall be selected by the Commission subject to approval by the Mayor and
10 confirmation by a majority vote of the Council. All positions shall be filled as soon as practicable
11 after the Council and Mayor have authorized the creation of the Commission. Staff from the
12 Department of Neighborhoods may provide appointment recommendations to both the Mayor
13 and City Council.

14 B. For the initial round of appointments, odd numbered positions will serve one-year
15 terms and even numbered positions will serve two-year terms. After the conclusion of the initial
16 terms, all subsequent terms of each position shall be for two years, with the exception of the
17 young adult position appointed pursuant to Chapter 3.51 who shall serve a one-year term. No
18 members shall serve more than two full consecutive terms. Any vacancy in an unexpired term
19 shall be filled in the same manner as the original appointment. A member whose term is ending
20 shall continue on an interim basis as a member with voting rights until such time as a successor
21 for that position has been appointed and confirmed by the City Council.

22 **3.62.040 Duties and functions**

23 A. The duties of the Commission include, but are not limited to, the following:

5 2. Advise the Department of Neighborhoods on the review of community
6 grant processes including input received from the District Councils, and make final
7 recommendations to the Department of Neighborhoods on proposals for Neighborhood Matching
8 Fund grants over \$25,000.

9 3. Meet at least ~~four~~ten times per year.

10 **3.62.050 Ancillary powers**

11 A. The Commission shall have the power to:

12 1. By a majority vote of the Commission, elect or replace one or more
13 Commission members to serve as Chairperson for a one-year term, and elect or replace one or
14 more members to serve as Vice Chairperson for a one-year term, who shall serve as Chair in the
15 absence of the Chairperson.

16 2. Organize itself, establish committees or subcommittees, and delegate
17 duties for the performance of its work; and

18 3. Adopt rules of procedure to accomplish its functions.

19 B. The Department of Neighborhoods shall provide staff support and meeting
20 facilities for the Commission and maintain its records. The Commission may also receive staff
21 assistance from other City departments.

22 C. Meetings of the Commission shall be open to the public and the Commission shall
23 operate subject to the Washington Open Public Meetings Act (chapter 42.30 RCW). Meeting

4 **3.62.060 Unexcused absences and removal**

5 Any member may request an excused absence. For City Council appointed positions, the Council
6 may remove any member who is absent from three or more consecutive meetings without cause,
7 or otherwise for cause. For mayoral and Commission appointed positions, the Mayor may
8 remove any member who is absent from three or more consecutive meetings without cause, or
9 otherwise for cause. The Commission may recommend, by a majority vote, that the Mayor or
10 Council remove any member who is absent without excuse from three consecutive Commission
11 meetings.
