Councilmember Harrell—

Well over a year since our October 15, 2013 letter, we can't find any response from you or your office. Your colleagues on the City Council tell us that you are lead person on this issue. We would appreciate your urgent help in having Eastlake included in an Alcohol Impact Area.

Eastlake was not included when Alcohol Impact Areas were established that cover South Lake Union, Capitol Hill, the University District and Wallingford. Now as a non-AIA, Eastlake is in the "doughnut hole," entirely surrounded by business districts that are AIAs. The result is predictable, with chronic public inebriates who are unable to purchase enriched beer or wine in those areas now coming to Eastlake to purchase these products, and with an apparent contribution to crime and disorder.

We certainly support voluntary efforts at compliance, including as the required first step toward being included in an Alcohol Impact Area, as well as any separate voluntary cooperation with industry that Seattle has been undertaking. However, these voluntary efforts are no substitute for Eastlake being included in an AIA. Being surrounded by AIAs, Eastlake will continue to suffer until it too is included. Please place Eastlake on a fast track to being included in an AIA.
