MONSTER STRUCTURE IN EASTLAKE

A huge building is planned for the shores of Lake Union. Marine Power & Equipment Co., owner of 400 ft of shoreline, has permits to build a barge fabrication plant on its property. The property is located north of St. Vincent de Paul's new building on the Southeast corner of the Lake and diagonally across Fairview from the City Light plant.

For over a year, Marine Power has its been storing castoff material, including an old decrepit ship on the site. Other than junk storage, the property has not been used productively during this time.

The proposed building will be large: 55 ft. tall, 300 ft. long, 150 ft. wide. Sea-going barges will be constructed inside the corrigated steel building.

Eastlake Community Council Board members voted to try to stop the construction of this building. We believe that a structure of this size is more appropriate for the Duwamish valley where heavy industry and proportionally large buildings are less harmful to residential and recreational interests (people).

The city rescinded the permit to build late last summer. Before Marine Power's appeal was even heard, however, the city attorney's office agreed to give up the fight. Although the recission was correct in substance, improper procedure was used, the city says.

ECC is now moving into the courtroom in effort to protect the city's earlier decision not to allow the monster building. Our neighborhood should not become another Harbor Island.

SR 520 LAW SUIT

The Eastside 520 Coalition has filed suit in Seattle to stop construction of the 520 "missing link" between Bellevue and Redmond. The coalition charges that State and Federal agencies have failed to comply with Federal and State environmental statutes. The state is planning to open bids for construction on October 18.

The group is part of the 520 Coalition, of which Eastlake Community Council is a member. In the suit. the Eastside coalition and concerned property owners contend that the state has failed to complete impact statements for all the various segments of 520 which would review the cumulative effects of continued expansion. They also contend that the EIS prepared for the link is inadequate; that the construction of the bridge over the Sammamish River requires a Federal impact statement which has not been done; and that construction in the wetlands violates a Presidential order banning such action.

If completed, this section of highway will cause increased traffic on the Evergreen Point Bridge and increase demands for a 5th lane. If the suit is successful, it will force the State to review its highway program for the route. Hopefully this will derive future benefits for our neighborhood.
