# OUR NEW GENERAL MEETING PLACE WILL BE ANNOUNCED NEXT ISSUE

There will be no general meeting of the Eastlake Community Council for September, due to the loss of Seward School as a convenient center. Usually, our general meetings are the THIRD TUESDAY of each month, from September through June. We hoped to continue this schedule. Sad to say, in trying to renew our permit to make use of the school facilities, we found that cutbacks in the School budget for custodial help has forced closing down of all Seattle elementary schools in the evening.

Our inquiries have disclosed that custodians will be on hand just one night each week. Perhaps we may find a way to coincide our meeting with the janitor's working day. This might mean changing our regular meeting night. We are also checking out other possible meeting sites.

THERE WILL BE A GENERAL MEETING NEXT MONTH. It will be the third week in October. The place and time will be announced in the OCTOBER NEWSGRAM. Notices will also be posted on local billboards prior to the meeting. In the meantime, please write us if you have any ideas for a new meeting place. It must be centrally located to the area, and accessible to the elderly and handicapped.

## Eastlake Rezone Problems Soon To Be Worked Out

Early in October, the Seattle Department of Community Development (DCD) plans to make public its recommendations for new zoning in the Eastlake residential areas, including multifamily areas.

This will be a milestone in our planning efforts with DCD since early this year.

Our committee, the Eastlake Technical Advisory Committee (TAC) has been advising DCD on both the residential and business areas, but many details of the business zones remain to be worked out.

By the end of October, there will likely be a public meeting in the Eastlake area to discuss (Cont'd. p. 2)

In October the City Council will consider adopting a "Master Use Permit" to be administered by the newly created Department of Construction and Land Use. The master permit will incorporate into a single permit numerous individual administrative decisions on land use now required for many projects.

Included will be permits based on zoning, shoreline, subdivision, and street regulations and environmental laws.

Hearings before City Council on the issues will be on October 2, at 7:30 p.m., in Council Chambers, 11th Floor, 600 Fourth Ave.


#### CANDIDATES NIGHT
