### EASTLAKE LAND-USE WINS.

We did it! The Multi-Family section of the Land Use Code and the new Land Use Map were adopted unanimously by the City Council May 10, 1982, then signed by the mayor on May 13. It has been a long and difficult process, but the new code will give our neighborhood a little more uniformity for new projects.

The new code dramatically changes the regulation of multi-family zoning in our neighborhood. If you want more information on the specific decision in regard to your lot or street, you may call or visit the Land Use Information Center on the fourth floor of the Municipal Building(625-5200).
