

RESIDENTIAL PARKING ZONE

There was a good turnout of Eastlakers at ECC's General Meeting on March 10 to hear about the proposed Residential Parking Zone (RPZ). After a presentation by the Engineering Department, there were many questions and voiced concerns. The current proposition would limit parking on qualified residential streets (included here is the map shown by the Engineering Department at the meeting; more streets will probably be added). On *one side of the street* parking would be limited to 2 hours between 7 a.m. and 6 p.m.; on *the other side* to 2 hours between 7 a.m. and 6 p.m. and no parking at all between 6 p.m. and 5 a.m. Residents can park at all times if they purchase an RPZ decal for a fee of \$27 payable every 2 years. Petitions must be signed by at least 60% of the residents. *Please sign the petition that will soon be circulated in your neighborhood.*

Suggestions sought -- As a part of the June 1991 settlement of our case over the Eastlake Center II building, Blume Eastlake Limited Partnership is scheduled to pay \$30,000 by June 1, 1992 to a "nonprofit organization or organizations designated by ECC, whose purpose is the improvement and/or acquisition of park property or the development or acquisition of low income housing." The two organizations that have so far been suggested as recipients of these funds are the Olmsted-Fairview Park Commission and the Eastlake Community Land Trust. CLEAN UP IN EASTLAKE


